**FROM I-71 TRAVELING NORTH –**

- 1) WARNING!!!: USE EXIT 19 AT THE MASON-MONTGOMERY/ FIELDS-ERTEL RD.  
EXIT AT YOUR OWN RISK. TRAFFIC IS OFTEN VERY SLOW.
- 2) I recommend you use EXIT 24, exiting I-71 NORTH at the WESTERN ROW RD./  
KINGS ISLAND DR. EXIT.
- 3) Turn LEFT at the light onto WESTERN ROW RD.  
(Away from Paramount Kings Island Amusement Park)
- 4) At the 3<sup>RD</sup> light turn LEFT onto WESTERN ROW RD.  
(The road becomes Tylersville Rd., leading to I-75, if you continue straight)
- 5) At the 2<sup>nd</sup> light turn LEFT onto MASON-MONTGOMERY RD.  
(Hope Church is on the right & the Western Row Golf Course is on the left)
- 6) At the 2<sup>nd</sup> light turn RIGHT onto CEDAR VILLAGE DR.  
(The First National Bank is on your right. Pass several 1-story buildings on the  
right & an open field on the left)
- 7) Turn RIGHT into the parking lot just past the 3-story brick building which has  
the script "CMC" Logo & the words, "OFFICE CENTER" on the side of the  
building.
- 8) Park and enter 7577 CENTRAL PARKE BLVD.  
(This is the mailing address. However, you are accessing the building from  
Cedar Village Drive)
- 9) Walk through the lobby into the hall on the RIGHT to Suite #112 .

**FROM I-71 TRAVELING SOUTH –**

- 1) Exit I-71 SOUTH at EXIT 25, the KINGS MILLS EXIT, just north of Kings Island
- 2) Turn LEFT at the light onto KINGS MILLS RD.
- 3) Turn RIGHT at the light onto KINGS ISLAND DR.
- 4) Drive through several traffic lights. (Right in front of the Kings Island Park)
- 5) Turn RIGHT at the light at the large intersection onto WESTERN ROW RD.
- 6) At the 3<sup>RD</sup> light turn LEFT onto WESTERN ROW RD.  
(If you continued straight, the road becomes Tylersville Rd., leading to I-75)
- 7) At the 2<sup>nd</sup> light turn LEFT onto MASON-MONTGOMERY RD.  
(Hope Church is on the right & Western Row Golf Course on the left)
- 8) At the 2<sup>nd</sup> light turn RIGHT onto CEDAR VILLAGE DR.  
(The First National Bank is on your right. Pass several more 1-story buildings on the right & an open field on the left)
- 9) Turn RIGHT into the parking lot just past the 3-story brick building with the script "CMC" Logo & the words, "OFFICE CENTER" on the wall.
- 10) Park and enter 7577 CENTRAL PARKE BLVD.  
(This is the mailing address. However, you are accessing the building from Cedar Village Drive)
- 11) Walk through the lobby into the hall on the RIGHT to Suite #112.

**FROM I-75 –**

- 1) Exit I-75 NORTH or SOUTH at the TYLERSVILLE ROAD EXIT.
- 2) Head EAST on TYLERSVILLE ROAD, past Krogers & Kohls.  
(You will pass a red & white radio tower on your left).
- 3) At the light turn RIGHT onto MASON-MONTGOMERY RD passing through several traffic lights.
- 4) At the 2<sup>nd</sup> light turn RIGHT onto CEDAR VILLAGE DR.  
(The First National Bank is on your right. Pass several more 1-story buildings on the right & an open field on the left)
- 5) Turn RIGHT into the parking lot just past the 3-story brick building with the script "CMC" Logo & the words, "OFFICE CENTER" on the wall.
- 6) Park and enter 7577 CENTRAL PARKE BLVD.  
(This is the mailing address. However, you are accessing the building from Cedar Village Drive)
- 7) Walk through the lobby into the hall on the RIGHT.  
Suite #112 is the 1st one on the RIGHT side.
